REGISTRATIONS AND CONFIRMATIONS

The deadline for Registrations, as per Organizational and Competition Information, is midnight on Wednesday, July 3, 2024.

Automatic confirmation will be provided at Bibs' Claim.

BIBS

Bib's handover will be held at Campo Sportivo Comunale – Pergine, from 3:30 p.m. to 7:30 p.m. on July 6, 2024.

TECHNICAL INFORMATION CENTER - T.I.C.

T.I.C. will be located at Centro Sportivo Comunale – Pergine, at the entrance to the area.

The service will follow all matters regarding: Bibs' pickup, Submissions of complaints and appeals (on second instance).

CLOTHING

Athletes are required to wear clubs' or national uniforms, during the race and the award ceremony. We remind that any kind of advertising, not approved by the RTI (International Technical Regulations), will not be allowed.

PERSONAL EQUIPMENT

It must be handed in within 60 minutes from the start of the competition at the T.I.C. and can be picked up directly at the platform at the end of the competition.

FIELD ACCESS

Athletes must enter the competition field through the Call Room and exit through the Mixed Zone.

RESULTS AND AWARD CEREMONY

In-kind prizes for winners.

The meeting is included in the Speed King and Queen Trentino – Alto Adige 2024 Circuit.

COMPLAINTS

Complaints regarding participation to the competition must be submitted to the Technical Delegate through the T.I.C.. Complaints regarding the proceeding of the competition must be submitted on first instance verbally to the Referee within 30 minutes of the results being made official, on second instance on written form to the Appeal Jury. The delivery of the appeal must be done at the T.I.C., accompanied by the prescribed fee of 100.00 euros, within 30 minutes from the negative decision of the first instance.

May be carried out in accordance with the provisions of the competent bodies, in compliance with current regulations.
